

#MUSICRUNMOMENTSWITHAFFIN GIVEAWAY CONTEST (SOCIAL MEDIA CONTEST)

TERMS AND CONDITIONS (“T&C”)

1. The “#MUSICRUNMOMENTSWITHAFFIN” (the “Contest”) is a social media contest organised by Affin Bank Berhad (the “Bank”) shall be subjected to the terms and conditions (“Terms and Conditions”) set out below.
2. This Contest runs from **17 April 2026 until 18 April 2026**, both dates inclusive, or such other period(s) as may be determined by the Bank (“Contest Period”) from time to time.

Eligibility

3. This Contest is open to all Malaysian citizens who are at least eighteen (18) years old, irrespective of whether they are customers of the Bank, or otherwise (“Participant”).
4. For the avoidance of doubt, employees of the Bank are eligible to participate in this Contest, save for those from the Strategic Communication Department.

5. The Contest will be conducted on the Bank’s official Instagram, Facebook, TikTok & Thread page with the username of @Affinmy (“Social Media Page”).
6. To be eligible and to stand a chance to win the Contest Prizes, the Participant(s) **must**: -
 - a) **Follow Us:** Participant(s) must follow the Bank’s Social Media Page by clicking the “Follow” button. No registration for the Contest is required.
 - b) **Like:** Participant(s) are required to view the Bank’s post published on its Social Media Page during the Contest Period. Participants must click ‘like’ on the Contest Post published on the Bank’s Social Media Page (Facebook, Instagram, TikTok & Thread)
 - c) **Tag @AffinMy with the Most Creative Run Moment:** Participant(s) must post their most creative run moment (photo or video) on their social media feed and tag @AffinMy during the contest period. Participants must ensure that their account is set to **public**.
 - d) **Use Campaign Hashtag:** Participant(s) must include the hashtag **#TheMusicRunByAFFIN & #MusicRunMomentsWithAFFIN** in the same posting
7. Participant(s) may submit a maximum of three (3) entries across any of their social media platforms. Each post shall be regarded as one (1) entry, and any entries exceeding the maximum of three (3) entries shall be disregarded.

8. Participant(s) must ensure that their submission remains publicly accessible on their social media account for a minimum period of **two (2) weeks** following the announcement of the campaign winner(s).
9. Participant(s) who meet the requirements will be evaluated by a jury, and the top three (3) most creative moments will be shortlisted as winners.
10. The Bank reserves the right to disqualify and/or delete any contest entry containing nudity, vulgarity, obscenity, racist sentiments, profanity, violence, or any other elements deemed inappropriate by the Bank.
11. The Bank shall not be liable for any contest entry that is disqualified or deleted, or for any entry that is not successfully posted due to technical issues, internet connectivity problems, or any other reason whatsoever.

Contest Prize Details:

12. The Grand Winner shall be awarded **one (1) unit of an Apple Watch SE**, while the remaining **two (2) winners** shall each be awarded **one (1) unit of Apple AirPods Pro** each (collectively referred to as the “**Contest Prizes**”).
13. All Contest Prizes are awarded strictly on an “as-is” basis and are **non-transferable, non-exchangeable, non-refundable, and not redeemable for cash or any other item**, whether in part or in full.
14. The Bank shall **not be responsible** for any **loss, damage, delay, personal injury, accident, or dissatisfaction** arising from the use of the Contest Prizes.
15. Any warranties, claims, or servicing related to the Contest Prizes shall be subject to the **manufacturer’s terms**, and the Bank shall not be held liable for the same.

Selection of the Winners:

16. The shortlisted participants with the most creative posting/moment, who meet all the criteria set out in the Contest Mechanics, will be selected as Winners by the AFFIN Jury.
17. The Bank will notify the Winners through an announcement post on its Social Media Page, which will be published **on or before May 2026** in conjunction with The Music Run by AFFIN 2026 (“Notification”).
18. The Winners are required to send a direct message to the Bank’s Social Media Page within two (2) days of receiving the Notification. The message should be sent from the same Social Media account used to comment on the Content Post and must include the following details to facilitate the prize redemption/ collection: -
 - a) Full name as per National Registration Identity Card (“NRIC”);
 - b) Mobile Number; and
 - c) Email Address.

In doing so, the Winners consent to their data being processed by the Bank for the purpose of Contest Prizes fulfillment only.

19. Winners are required to keep their Social Media Direct Messages enabled to receive messages from the Bank regarding prize redemption.
20. Apart from the personal data mentioned in Clause 18 above, the Bank will not ask for any other personal and/or banking details such as residential address, credit card/debit card number, login password, one-time password (OTP) number or bank Transaction Authorisation Code (TAC) for the purpose of this Contest.
21. The Winners shall be contacted separately in relation to the prize collection process. The consolation prizes shall be delivered to the respective winners via email.
22. In the event that the Winners fail to message the Bank with the required details within the specified timeframe, or if the Bank is unable to contact the Winners due to their privacy settings, or if the Winners do not collect their Contest Prizes within the stipulated period, the Winners will be automatically disqualified and their entitlement shall be deemed void. The Bank reserves the right to select a new Winner as a replacement.
23. All terms relating to the issuance, redemption, and usage of the Contest Prizes are subject to the terms and conditions imposed by Affin Bank Berhad ("the Bank"). In the event of any disputes relating to the Contest Prizes, the Winners shall deal directly with the Prize manufacturer.

General Terms and Conditions

24. By participating in this Contest, the Participant(s) agrees to be bound by these T&C, including any amendments or variations made hereto.
25. This Contest ends on 18 April 2026. However, the Bank reserves the rights to change, amend and/or modify any terms of these T&C including the Contest Period, wholly or in part, from time to time, by giving twenty-one (21) calendar days' prior notice to the Eligible Participant(s). Such notice will be posted through AffinAlways.com.
26. **The Bank will not be held responsible or liable for:**
 - (a) any actions, claims, losses, damages, costs, charges, and expenses which the Eligible Participant(s) may suffer, sustain or incur by his/her participation in this Contest except where such actions, claims or losses are directly caused by the Bank; and
 - (c) any default of its obligations under this Contest due to any force majeure event, which includes but is not limited to acts of God, war, riot, lockout, industrial action, fire, flood, drought, storm, pandemic, epidemic or any event beyond the control of the Bank.
27. By participating in this Contest, the Eligible Participant(s) agrees to regularly access the Bank's website at AffinAlways.com to view these T&C and stay updated on any changes or variations.
28. These T&C, including any amendments, deletions, or additions, shall prevail over any provisions or representations contained in any other promotional materials advertising this Contest, only insofar as they are relevant and applicable to the Contest.

29. The Eligible Participant(s) confirms that he/she has read, understood, and agreed to be bound by the Bank's Privacy Notice, available at the Bank's branches or on the Bank's website at AffinAlways.com. Unless the Eligible Participant(s) expressly opts out by contacting any of the Bank's branches, the Bank may market the products of AFFIN Group (as defined in the Privacy Notice) or those of its associate/affiliate companies to the *Eligible Participant(s). For the avoidance of doubt, the *Eligible Participant(s) agrees that the said Privacy Notice shall be deemed to be incorporated by reference into these T&C.
30. These T&C shall be governed by and construed in accordance with the laws of Malaysia, subject to the exclusive jurisdiction of the Malaysian Courts.
31. Any cancellation, termination, suspension or extension to this Contest or the Contest Period shall not entitle the Eligible Participant(s) to any claims or compensation against the Bank for any losses or damages suffered or incurred as a direct or indirect result, except where such losses or damages sustained are caused by the Bank's negligence, default or breach.
32. The Bahasa Malaysia version of these T&C is available at AffinAlways.com. If there is any inconsistency, conflict, ambiguity or discrepancy between the Bahasa Malaysia and English versions, the English version will prevail. However, if the Eligible Participant(s) requests and the Bank acknowledges in its records that the Bahasa Malaysia version shall govern the operation of this *Promotion/Campaign/Contest, then the Bahasa Malaysia version shall prevail.

If the Eligible Customer(s) is under the age of eighteen (18) years old, the parent or legal guardian must own the copyright of the image and warrant to the Bank that all relevant consents of third persons contained in the image have been obtained with respect to its use and publication.
